To comply with the current Data Protection laws, we need your permission before we Create, Store and Use the personal data. Therefore, by continuing to access our website or communicating with us you agree with the information below and give us your permission.

Please be aware that any or all the personal data provided by yourselves may be required by Humber Martial Arts and its officials (Inc. other parties*) to fulfil various tasks, for example:

Example Personal Data:

Name and Address details including Phone numbers, Email Addresses and Social Media data, Height, Weight, Age (D.O.B), Gender, Criminal record, Occupation, Health record (Illness/diseases), Photos/videos – Digital and non-digital personal images, any other paper based and digital forms of personal data.

Example Tasks:

- Personal Data required to make phone calls/text messages and send emails using any digital platform
- Personal Data required for the production and storage of various documentation
- Personal Data required for personal and club promotional materials (e.g., digital, and non-digital)
- Personal Data required to arrange Insurances (e.g., member to member liability/accident cover via the use of a broker*)
- Personal Data required to arrange Tournaments/competitions (e.g., Entrance to event, travel details, accommodation details)
- Personal Data required for use on the internet, e.g., club website, social media, email (owned by Humber Martial Arts and its officials personally)
- Personal Data required for purchase of goods

The examples of data, creation, usage, and storage of data within this document are not a comprehensive list.

What we may collect:

- Questions, queries, or feedback you leave, including any personal information you share if you contact us at Humber Martial Arts (via all forms of electronic/ non electronic methods of communication)
- Your email address and subscription preferences when you sign up to our email alerts, and how you use our emails for example whether you open them, and which links you click on
- Your Internet Protocol (IP) address, and details of which version of web browser you used
- Information on how you use the site, using cookies and page tagging techniques

This data might be viewed by authorized people in Humber Martial Arts to:

- Improve the site by monitoring how you use it
- Gather feedback to improve our services, for example our email alerts
- Respond to any feedback you send us if you've asked us to
- Send email alerts to users who request them
- Allow you to access our services and make transactions
- Provide you with information about our services if you want it *Methods of receiving, storing, and using your personal information will vary dependent on the techniques in use at the time.

Keeping your data secure:

Sending information over the internet is not completely secure, therefore we can't guarantee the security of your data 100%. Any data you send is at your own risk.

Disclosing your information

We may pass on your personal information if we have a legal obligation to do so. This includes exchanging information with government departments for legal reasons.

We may pass on your personal information for personal, safety and legal purposes; for example, obtaining Martial Arts Equipment or Insurances etc. to third parties to ensure the best possible service and products can be sourced.

We won't share your information with any other organisation for marketing purposes.

Your rights
